

Herbal Quitacoff

Therapeutic indication:

English Herbal Medicines Herbal Quitacoff is a traditional herbal medicinal product used for the relief of coughs, such as chesty coughs and dry, tickly coughs, based on traditional use only.

Components:

Each 5ml of oral liquid contains 0.065 ml of liquid extract from dried Lobelia (*Lobelia inflata* L.) herb (1:1). Extraction solvent: ethanol 50% v/v and 1 ml of liquid extract from dried Squill (*Urginea maritima* L.) bulb (1:10). Extraction solvent: acetic acid (5.8 % w/v). Also contains Glycerol and Concentrated Apple Juice.

Dosage:

For the relief of coughs, such as chesty coughs and dry, tickly coughs: Take one 5ml teaspoonful three or four times a day.

Enviro Friendly Label and Packaging:

Almost zero new paper packaging is produced for the manufacture of this product. The Patient Information Leaflet is found behind the peel-and-reseal front label. There is no bottle box and product is re-delivered in the same outer card wrapping that the empty bottles are received in by the final dosage form manufacturers (subject to quality checks).

Pack Size:

Available in 200ml amber glass bottle with 20mm screw top. Supplied in boxes of 10 bottles. Nominal weight per box of 10 is 4.4 kg.



Squill and Lobelia

The Squill and Lobelia combination formula for Quitacoff was a traditional herbal remedy originating from Potters, the first English herbal medicine company, founded in 1812 and which grew to become the main UK supplier of medicines in the nineteenth century.

Squill is one of the earliest known plants in medicine. The earliest mention is in the Ebers papyrus. So effective that it became an object of temple worship. Its modern use is for 'dry' respiratory conditions in need of a positive expectoration¹.

Lobelia, also known as Indian tobacco, is an expectorant and was once also used as a smoking deterrent², which may have given rise to the old name "Quitacoff"

Squill was recommended in the 17th century by Culpepper as "it is one of the most certain expectorants in asthmatical cases, where the lungs or stomach are oppressed by tough viscid phlegm, or injured by the imprudent use of opiates."³

Both Squill and Lobelia are listed as official drugs in the British Pharmacopoeia, as long ago as 1885⁴ and were constantly in the Pharmacopoeia throughout the succeeding century⁵. Few drugs have stood the test of time so well.

In the USA, it was said that "for laryngitis...we have no remedy equal to Lobelia"⁶, whilst in Britain, squill was "a powerful expectorant, and is much used in chronic bronchitis and for coughs generally."⁷

“Stimulating (reflex) expectorant herbs like Lobelia and Squill(s) have been standards in Western Medicine. Limited modern investigation of the mechanisms involved leads to thought that they are mediated through both peripheral and central 5-HT₃ receptors.”^{8,9}

The British Herbal Pharmacopoeia says that both Squill and Lobelia are specifics for cough, with scanty sputum.¹⁰
